

BIGHORN RANCH EQUINE BOARDING CONTRACT AND RELEASE AND HOLD HARMLESS AGREEMENT NOTICE

A Person who is engaged for compensation in the rental of equines or equine equipment or tack or in the instruction of a person in the riding or driving of an equine or is being a passenger upon an equine is not liable for the injury or death of a person involved in equine activities resulting from the inherent risks of equine activities as defined in section 895.48 (1)(e) of the Wisconsin Statutes.

EXPRESSLY ASSUME ANY AND ALL RISK OF INJURY OR LOSS TO MY HORSE, PERSON OR PROPERTY AND RELEASE Bighorn Ranch, Mary Spanton, their employees, agents, successors, heirs, legal representatives and assigns from any and all claims whatsoever which I may hereafter incur on account of or in any way growing out of any injury and/or damage to person, property or animal or the consequences thereof, resulting from any accident, casualty or event involving me or members of my family, or my guests and arising out of equestrian activities associated with Bighorn Ranch, Mary Spanton, whether or not such injury or claim resulted directly or indirectly from the negligence of any of the named parties.

I further, **COVENANT** to never institute any suit or action against the above named for reason of any claim related to say equestrian activities;

I shall **INDEMNIFY** and save the parties named harmless against any and all further claims and damages, costs or expenses which might be incurred by me or any member of my family or guests, or my horses arising as a result of participation in said equestrian activities whether or not said claim resulted directly or indirectly from the negligence of any of the named parties. I also agree to indemnify the named parties for damages incurred as a result of any accident or injury that may be caused by my own negligence during participation in equestrian activities through Bighorn Ranch, Mary Spanton.

I also understand that it is my responsibility to carry my own insurance on my animal or equipment that I or my family personally own.

Private Paddock with 12X12 shelter; 6-8 slabs hay per day (up to 25lbs) or netted round bale	\$10/day; \$50/week; \$175 per month
Pasture with lean-to shelter; Round bale hay	\$125 per horse
Stall board with bedding provided	\$15 per day or \$290 per month

- Board is due on the 1st of the month. Late payments will be charged \$10/ horse after the 1st.
- Board includes up to 25 lbs hay per day, water, use of round pen, arenas, tack storage and fly control.
- Renters must supply any other feed.
- Special care (medications, wormer, grooming, farrier, and exercise) are the owner's responsibility.
- Minors under the age of 16 must have adult supervision.
- Please clean the tack area before leaving.
- Your friends are welcome at Bighorn Ranch; please have them sign a waiver of liability before hand and place in the folder in tack area.
- When late payments for board exceed \$600, the horse(s) above will be surrendered to Bighorn Ranch.

I have read the above contract and release of liability, and agree to all that is stated herein. I also agree that my horse(s) are free of any disease and worms and will provide proper veterinarian care when needed.
